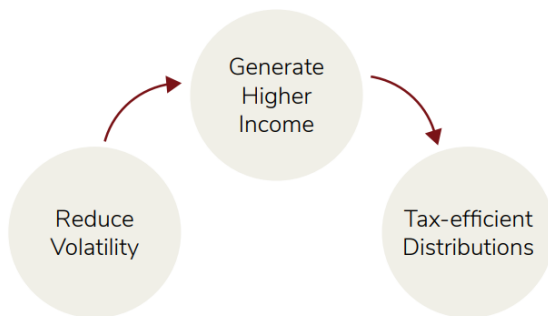

Investment Objective

LMAX is designed for attractive monthly income, while providing exposure to an equal-weight portfolio of primarily U.S. large-cap healthcare companies. To reduce volatility and augment dividend income, LMAX will employ an active covered call strategy. LMAX does not use leverage.

What Makes LMAX Different?



Many covered call ETFs write options on ~30%-50% of portfolios, out-of-the-money



LMAX is able to provide higher monthly income with a dynamic covered call strategy, currently writing options on ~30% of the portfolio, at-the-money, which offer higher premiums



This allows LMAX to generate higher options premiums while maintaining ~70% upside potential
