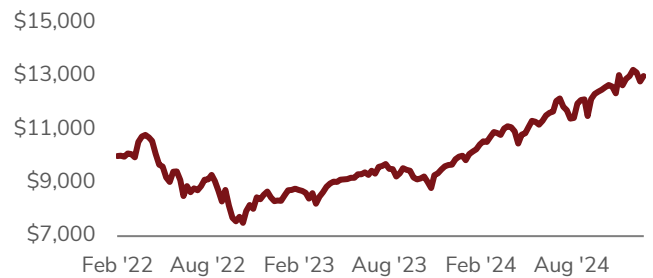

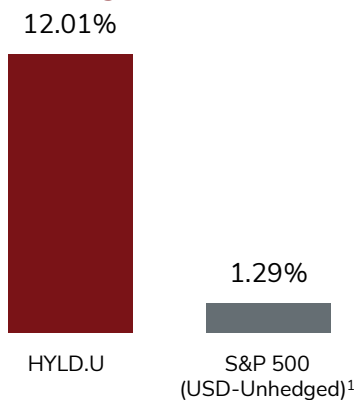

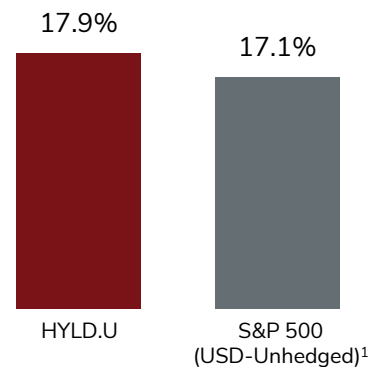

**Similar Volatility to S&P 500<sup>1,4</sup>**



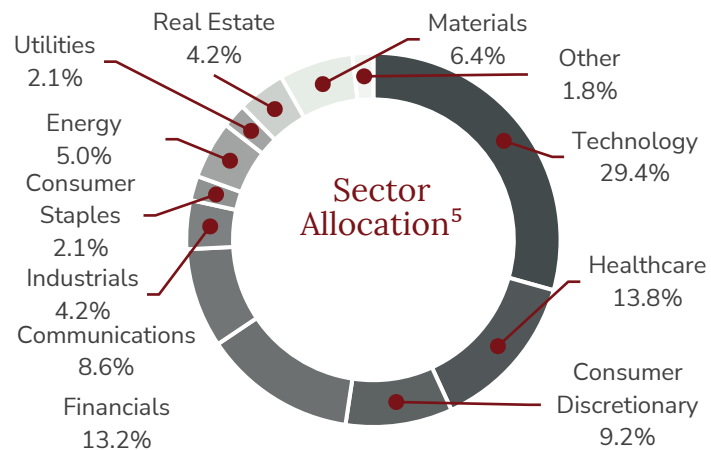
