- Modest 25% cash leverage to enhance growth potential and monthly income.

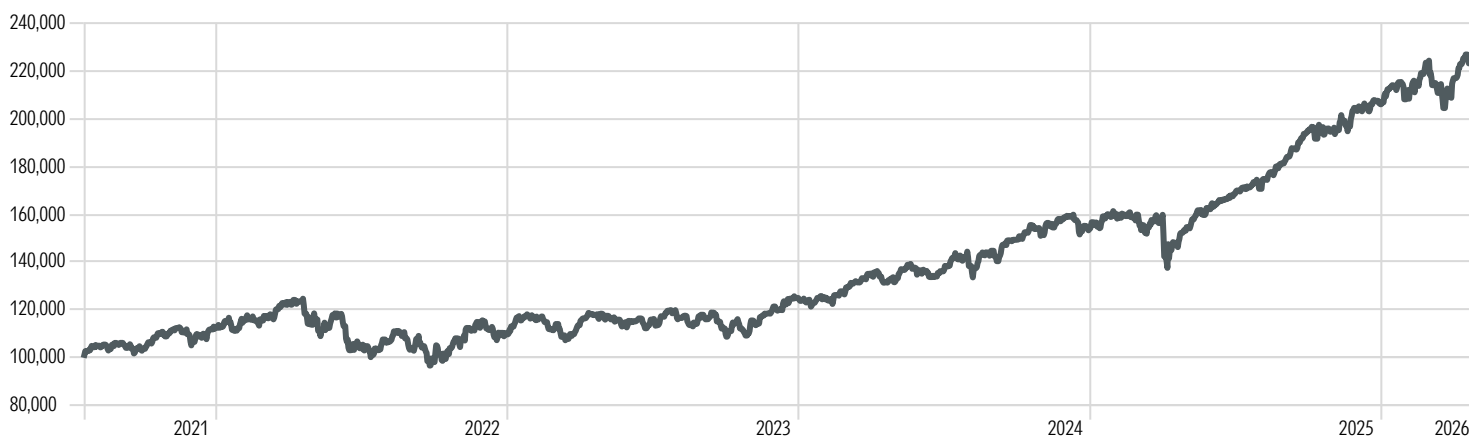

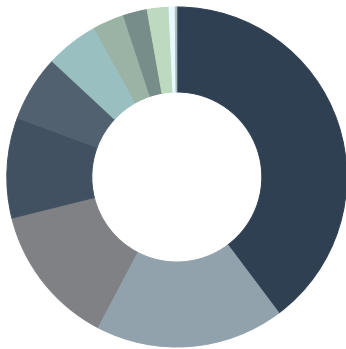

## Sector Allocation

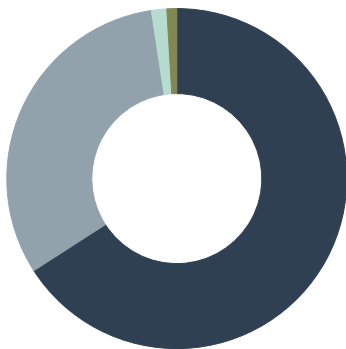
