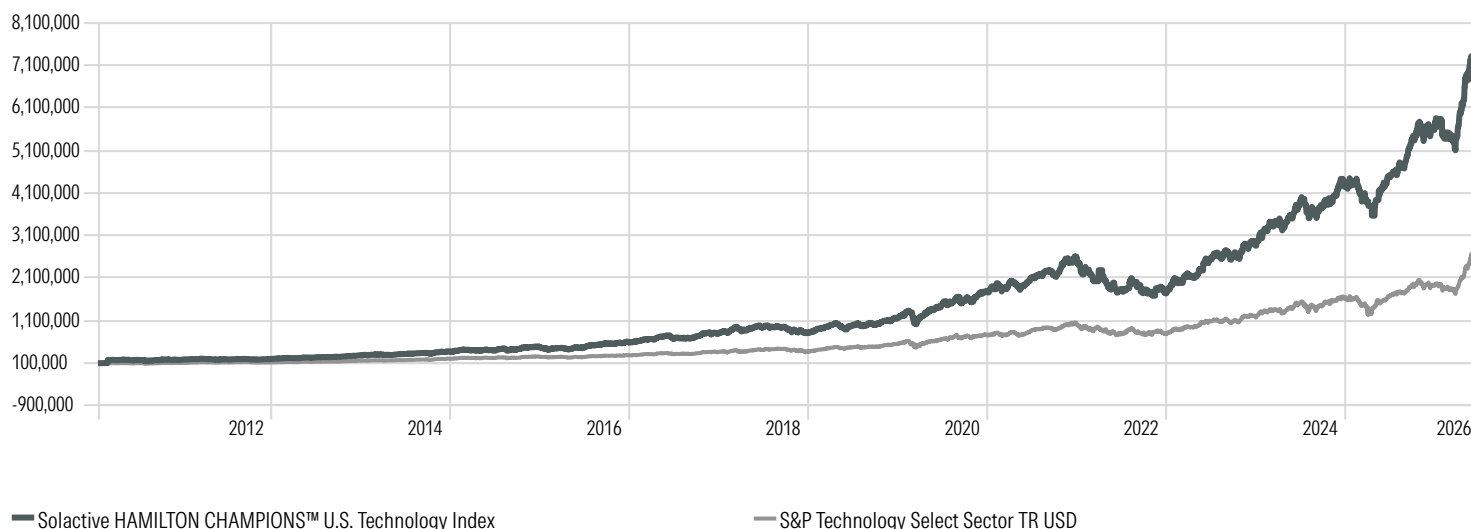

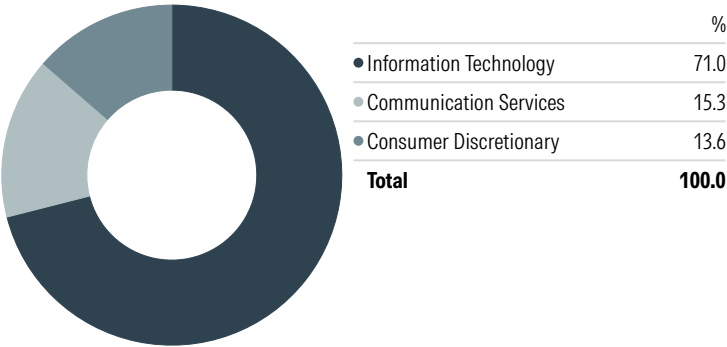

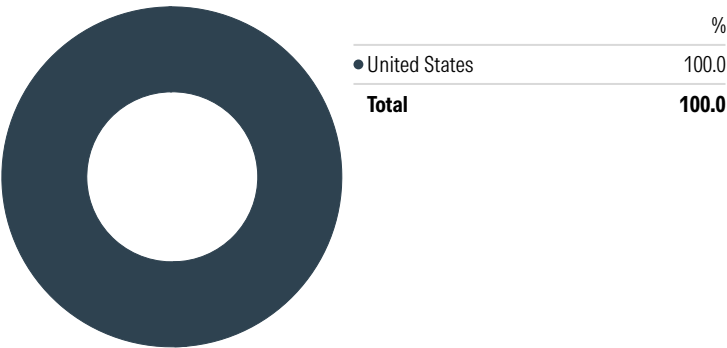
Sector Allocation
